The Peace Conferences of 1919–23* (Haus Publishing, 2011) și *A Concise History of Romania* (Cambridge University Press, 2013). He was an honorary member of the Romanian Academy (1991).

He was an IREX and Fulbright scholar in Romania in 1971-1973, 1982-1983, and 1989-1990. His book, *Romanian Politics, 1859-1871: From Prince Cuza to Prince Carol* was selected by

*CHOICE MAGAZINE* as an Outstanding Academic Book for 1998 and was awarded the 2000 Bălcescu Prize for History by the Romanian Academy.
